A DISTRICT BOARD OF EDUCATION SHALL PAY AID IN LIEU OF TRANSPORTATION TO THE PARENT OR GUARDIAN OF AN ELIGIBLE STUDENT ONLY AFTER RECEIVING A SIGNED "REQUEST FOR PAYMENT OF TRANSPORTATION AID" VOUCHER AS PRESCRIBED BY THE COMMISSIONER OF EDUCATION.

## NEW JERSEY STATE DEPARTMENT OF EDUCATION PRIVATE SCHOOL TRANSPORTATION DETERMINATION OF ELIGIBILITY

- 1. The Public School district from which private transportation is being requested must be a district in which transportation is provided for remote public school pupils.
- 2. Remoteness defined:
  - K 8 PUPIL, a distance of 2 miles or more from their home to assigned school.
  - 9-12 PUPIL, a distance of 2.5 miles or more from their home to assigned school.
  - To ascertain remoteness, the distance shall be measured via the shortest public roadway or walkway from pupil's home to assigned school.
- 3. Private School must be within the State and not more than 20 miles from pupil's home.

## PARENT APPLICATION

- 1. Parent(s) or guardian(s) of private school pupils shall secure pupil transportation Application Form (B6T) from the administrative office of the private school in which the pupil is enrolled.
- 2. Upon completion by the parents, the form shall be returned to Oratory Prep School.
- 3. The public school shall notify the parent and private school as to the disposition of the application by August 1.

There is a State reimbursement paid through the local Boards of Education for the eligible private school students not provided with bus transportation by the local Boards. The amount of the annual reimbursement for 2023-2024 is determined by the local Boards of Education. As stated above, in order to qualify, you must reside in a town where the Board of Education buses their own students and, you must file an application (B6T).

Students from the following towns are NOT eligible, since these Boards of Education do not provide bus transportation for their own students. Therefore, if you live in the following towns; please return the B6T with a notation saying Does Not Apply. No need to fill the form out completely.
